

The Cannon Co Election Commission met on April 8, 2013 with all members present. Mike Grosch was welcomed. AOE Mankin and deputy Young in attendance. 20 Visitors were present. 1) Matt Studd presided and called the meeting to order.

2) Matt Studd led the prayer.

3). Sue Patrick led the pledge

Before remaining business Corey Davenport expressed concerns that he had got a phone call stating he was conspiring with Gannon and Patrick. He asked each of them if we have had conversations regarding the election commission. Patrick and Gannon each stated no. Davenport stated he had not ever had conversations with them regarding the commission.

4) Election of Chairman. Gannon made a motion to elect Davenport with Patrick seconding. Grosch stated he was listening to figure out the procedures. Davenport was elected chairman. Patrick, Gannon, Studd voting yes.

Davenport thanked Jim Hill for serving. Gannon thanked Mankin for a good job and stated she was now certified.

5) Discussion about the secretary position job was had. Patrick did not desire the job nor Gannon. Mankin stated either she or Young could be paid to take the minutes. Patrick stated she would accept the position. Gannon made the motion to nominate Patrick with Grosch seconding. Gannon, Grosch and Davenport voted yes. Motion carried.

6.) Hiring AOE Davenport spoke about appointing an interim AOE thru April and taking applications. Studd addressed that there were two certified for the position Mike Grosch stated he would like to talk to Mankin and Dobson who were both certified and get information from them. Gannon made a motion to hire Mankin with Patrick seconding. Studd expressed a desire to hire Dobson. He stated no complaint had been sent to Nashville and discussed how the state removed Mayo for acting in a retaliatory manner. The state took action Studd referred to the county HR Manual page 5 regarding nondiscrimination. Patrick stated the commission took action when we fired Dobson. Grosch seconded Studd's motion to nominate Dobson. A vote was taken to elect Mankin. Gannon, Patrick, and Davenport voted yes with Studd and Grosch voting no. Patrick Had not heard Davenport's vote and believed there was a tie but Davenport stated he voted to hire Mankin.

7. Read and approve minutes. Gannon made a motion to accept without reading and Studd seconded. All in favor

8. New voter registrations 18 were reviewed. Most were from the Dept of Safety.

9. AOE spoke about the Taceo meeting June 16-19. It will be in Memphis. She urged commissioners to attend. There is training on the website with possibly a CD.

The upcoming budget was mentioned. 2071 confirmations of voters has been sent according to Mankin. 433 have been returned and 421 have been returned from post office. These voters if stay inactive will be purged in 2017. They have not voted in past 2 November elections. One is in the nursing home and cannot be purged.

How items would be suggested for the agenda was discussion. It was decided to contact Mankin.

A motion was made to include minutes on the website. Studd made the motion with Grosch seconding. All in favor.

Studd presented bill for two flash drives to furnish the attorneys and he is to be reimbursed. Gannon made motion to adjourn with Patrick seconding. Meeting adjourned.
