The Cannon County Election Commission met on November 17, 2014 in their regular Monthly meeting. All members were present along with AOE Mankin. Scooter Mankin was the only visitor present.

1. Chairman Davenport called the meeting to order
2. Studd led the prayer.
3. All recited the pledge.
4. Grosch made a motion to approve the October minutes and Gannon seconded. All in favor.
5. 48 new voter registrations were reviewed by Grosch and Patrick. No irregularities were found.
6. AOE Mankin gave a report which included the upcoming TACEO meeting. She stated Rachel, Matt Studd and herself would be attending.
7. The November election was certified and the documents signed.
8. Dekalb County's policy was handed out and reviewed regarding cameras and videos in the 100 ft boundary. A voter had posted his own ballot. Patrick made a motion to table and Gannon seconded until the enforcement power could be ascertained. All in favor.
9. The December meeting will be held at the election office and notice will be Posted. Gannon made the motion with Studd seconding. All in favor. Studd mentioned violations he found on election day such as provisional tables being in too close proximity to the other workers, election signs within 30 ft at Woodbury. Mankin stated she would make pictures and mark off boundaries before the next election. Westside had problems with doors and gates and the lady who fell broke her kneecap and twisted her ankle. This has been turned over to insurance. A ramp will be needed for the door in the future. Eastside, Woodland and Short Mountain was found to be 100%. Gassaway and Auburntown were good. Studd made a motion to prorate election workers pay if they leave early. Grosch seconded. All in favor. Studd stated this should be the same for commissioners. Studd made a motion with Grosch seconded. Motion passed.  
Patrick mentioned that we needed to be more thorough in selecting election workers. She wanted us to look at the parties represented closer because she believes this has gotten out of balance. Discussion was had but no action taken.
10. Gannon made the motion to adjourn and Grosch seconded. Meeting adjourned.
